NON-MEMBER EVENT PARTICIPATION FEE: A fee of \$3.00 will apply to non CKC member owned dogs entered in this event. Please ensure that you supply the owners CKC member number on your premium or this fee will be applied.

GAME BIRDS: Ducks or Pheasants may be used in all stakes.

PRIZES: CKC rosettes will be awarded to all dogs who place or are awarded a C.M.

HEADQUARTERS: Will be located at Ebenezer Kennels, 1994 Wood Road, Wyebridge, Ontario. Test sites will be well signed from major intersections in the area as well as from headquarters.
