DIRECTIONS:

As we have no official headquarters, below are directions to the corner of Hwy's 20 and 58, where you will see Danny's Esso Station. All signs for each stake will be clearly visible from this corner on the day of that stake. From Toronto, QEW to Niagara. Exit at Hwy. 406 to Welland. New overpass at Hwy. 20, so go towards Niagara over liftbridge to light at intersection of Hwy. 20 & Hwy. 58. From U.S., take the QEW to the Thorold Stone Rd. exit, to Thorold. Turn left on Hwy. 58. Continue to Hwy. 20.
