All participants must be familiar with Chapter 5, Section 2 of the Field Trial Rules and Regulations. In summary, it provides that any Person participating in a Trial shall not be subjected to an indignity of any kind. Violations of this rule shall be dealt with in accordance with the rules and regulations of the Canadian Kennel Club.

Notes:

1. Bitches in season may not compete and must be withdrawn.
2. REFUNDS: Full refunds will be given for any dog withdrawn because of estrus, injury, illness or death. Other refunds (less a scratch fee of \$10.00 per dog) may be given for good cause at the discretion of the field trial committee. All requests for refunds must be in writing and must be received within 2 days of the last day of the trial and, unless otherwise agreed by the field trial committee, must be accompanied by a Veterinarian's certificate.
3. Males and Females will be run in the order of the draw. Any dog not appearing within 15 minutes of its time to run may be disqualified.
4. Ducks will be used in all stakes.
5. Standard CKC rosettes and keepsake awards will be awarded.

Dead ducks will be used in this trial. Males and females will be run in order of the draw.

A system of rotation will be used for the start of subsequent series.

Female dogs will not be vetted and handlers are reminded that bitches in estrus cannot compete in a CKC Licensed Trial.

TRIAL HEADQUARTERS will be at the Beaver Lake Retriever Ponds.

Catalogues will be available from Debby Montgomery at the VIRC Spring Trial April 24th & 25th or on April 28th at the trial.
