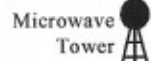

DEFINITION OF STAKES

- JUNIOR HUNT TEST.....For dogs over 6 months of age, that have not received a qualifying score in a Senior or Master Hunt Test
- SENIOR HUNT TEST.....For dogs over the age of 6 months that have not received a qualifying score in a Master Hunt Test
- MASTER HUNT TEST.....For dogs over the age of 6 months
