Bitches in season may not compete and must be withdrawn. Entry and listing fees paid for any dog withdrawn because of estrous, injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the Field Trial Secretary prior to the start of the stake to qualify for a refund

Any person, participating in any capacity at the Field Trial held under these CKC rules, shall not be subject to any indignity of any kind during the progress of the trial, and it shall be the duty and obligation of the club holding the trial to see that this rule is effectively enforced. On report to the trial giving club of an alleged indignity of any kind, the Field Trial Committee of the club shall forthwith conduct an investigation and shall at once render its decision to the parties concerned. It shall also, within 10 days after the trial, report to the CKC the nature of the alleged indignity, the names of the parties concerned and its findings. The Discipline Committee of the CKC shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
