ENTRIES: Please complete one entry form per dog, per stake, per day in which you wish to enter your dog(s). All entries must contain complete information as required by the CKC rules. All entries must be accompanied by the entry fee in full, and all listing fees (\$8.61 including GST) where applicable. A listing fee as established by the CKC must accompany the entry of a dog for which a CKC individual registration number is not shown on the entry form or ERN notice. Scratches will be refunded for a bitch in season totally. All other scratches will be refunded at the field trial committee's discretion, other than a fee of \$5.00.

RULE 21.7 of the Field Trial Rules States: "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

RULE 4.1.6 of the Field Trial Rules States: A trial secretary shall assume the responsibility of collecting all listing fees for the CKC, which shall be stated in the premium list."

NEW CKC RULE: Non-Member Participation Fee - An annual non member participation fee for awards (placings) will be charged to all Canadian residents who participate in CKC events but are **not** CKC members. This fee will match the ERN fee. These fees only apply to dogs who are wholly owned by Canadian residents who are non CKC members.

Release and indemnification of Landowners and Red Deer Retriever Club

By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog, or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all of his heirs, executors and assigns.

Placings are as follows: First - 5 points, Second - 3 points, Third - 2 points, Fourth - 1 point.

Prize list: Standard CKC rosettes to the first four placings in each stake.

Certificates of Merit will be awarded at the Judge's discretion.

Ducks and/or Pheasants will be used in all stakes.

A system of rotation will be used in the All-Age stakes. The starting dog in the all age stakes will be determined by the two digits of the TSX close on the Tuesday immediately preceding the trial.
