On report to the trial- giving club of an alleged indignity of any kind the field trial committee of the club shall forthwith conduct an investigation and shall at once render a decision to all parties concerned. It shall also within ten days after the trial, report to the CKC the nature of the alleged indignity, the names of the parties concerned and it's findings. The Discipline Committee of the CKC shall have the power to take such action as it deems fit on receipt of the report indicating that this rule has been violated.

Caution: The Brandon Retriever Club will not be responsible for any loss or damage to any dog or to and equipment as the result of an accident or otherwise. Furthermore, the Brandon Retriever Club will assume no liability in the event of an Accident of other misfortune to participants, bystanders, club members, workers or other individuals using the property for any purpose.

**DEFINITION OF STAKES**

PUPPY For dogs 6 month of age but not over 1 year on the day of the trial  
JUNIOR For dogs not over 2 years on the day of the trial  
QUALIFYING For dogs how have never won 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> or a certificate of merit in an Open All Age stake nor a 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, or 4<sup>th</sup> in an Amateur All Age Stake nor have won 5 Qualityings  
OPEN ALL AGE For dogs over 6 months of age  
AMATEUR ALL AGE For dogs over 6 months if handled by a person deemed an Amateur by the Field Trial Committee
