CKC registration or ERN must be applied for within 30 days of the trial or all wins and awards will be cancelled. Scratches: Entry fees will be fully refunded for a bitch in season when a vet certificate is provided. All other scratches will be refunded at the Field Trial Committee's discretion, minus an administration fee of \$10. Make all fees payable to the Logan Lake Retriever Club.

Please note: Canadian resident non-CKC members running a wholly owned dog cannot win a placement unless they pay a non-member participation fee or a membership fee to the CKC.

Dead Ducks will be used at this trial. Males and females will be run in order of the draw. A system of rotation will be used for the start of subsequent series in the All-Age Stakes. Wingers may be used in all stakes. Female dogs will not be vetted and handlers are reminded that bitches in estrus cannot compete in a CKC Licensed Trial. Eliminated dogs will be allowed to run out of contention in the minor stakes as time allows.
