All entries must be accompanied by the entry fee in full. Any dog not registered with the CKC must include a listing fee **(\$9.40, GST included)**. A CKC registration or ERN number must be applied for within 30 days of the Trial or all wins and awards will be cancelled

**SCRATCHES:** Fees, less five dollars, will be refunded (at Field Trial Committee's discretion) upon application within 14 days of the trial. Bitches in season and injured dogs may not compete and must be withdrawn. Fees will be totally refunded but a veterinary verification may be requested.

**NOTE:** Ducks and/or pheasants will be used in all stakes.

The running order for all stakes will be published on our web site [www.wrrc.ca](http://www.wrrc.ca) & NRCC web following the draw and before the TSX closing on Thursday June 4, 2015. The TSX closing method of selecting the starting dog in Open and Amateur will be used (Closing final two digits on TSX on Thursday June 4, 2015). The Running order in the Open and Amateur will be done on a rotation basis for the subsequent tests. The rotation will be posted in the first holding blind on the first test.

**NOTE:** If junior Stake entry numbers are low the Stake may be combined with the Qualifying Stake

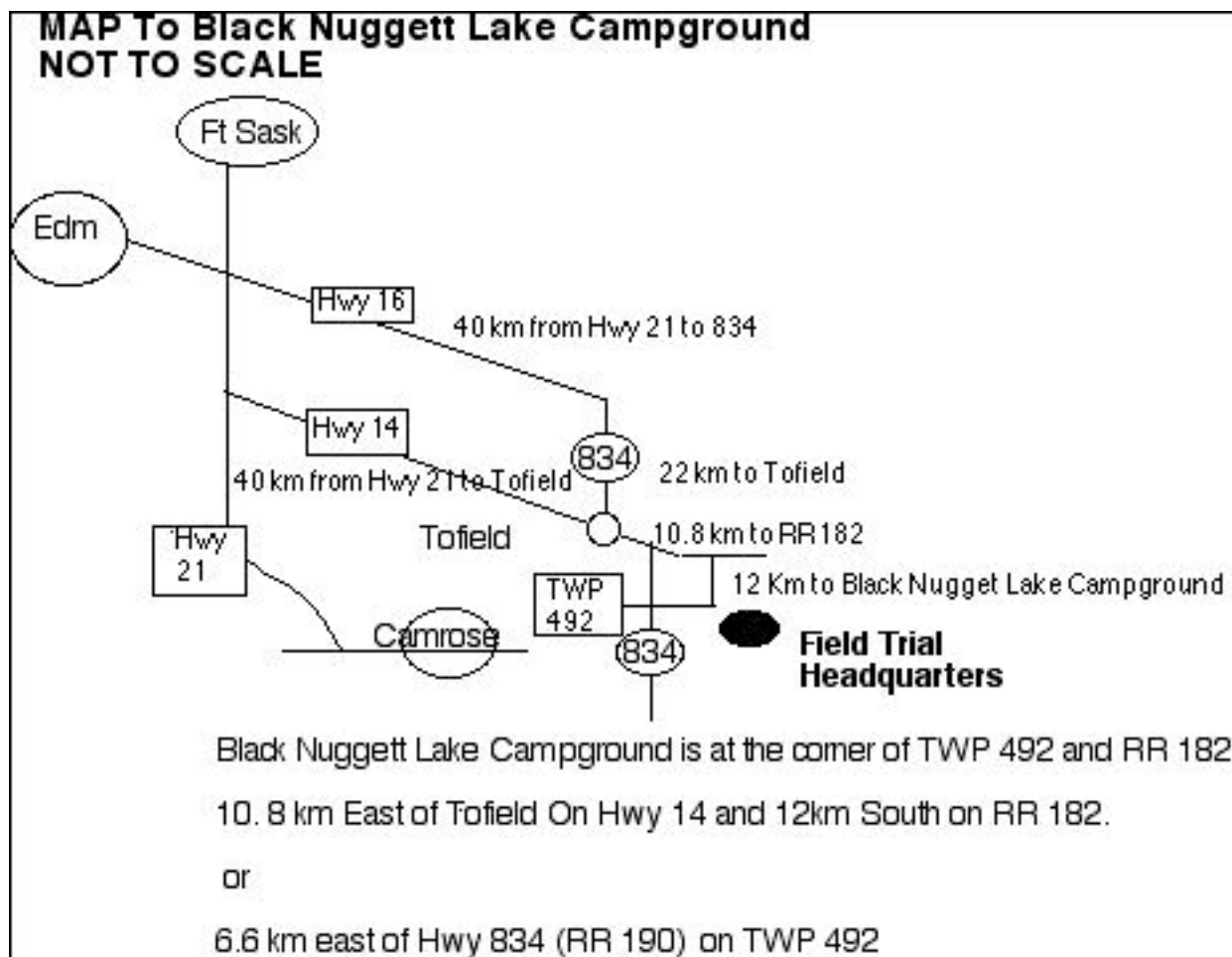
**Release and Indemnification of Landowners**
