Judges will impose a system of rotation thereafter in the all age stakes. Dogs will run in order of the draw with sexes mixed. Running order will rotate in the Open & Amateur stakes.

Directions to Gahonk Kennels: Exit Highway 401 at exit 509 (Hwy 30). Follow Telephone Road (east) to the first stop (County Road 26). Turn Left (north) on County Road 26 for approximately 2 km. Turn Right onto Long Reach Rd. and follow to the end of the road .

Jim Green's: 249 Ridge Road

Take 401 east to Exit 556, 1st exit east of Belleville.

Go south on Shannonville Road to the end.

Turn left on Hwy 2 then immediately right on York Road.

Cross the bridge, turn right on Queen Street, then left on Beach Road.
