GAME: Dead ducks will be used in all stakes

NOISE MAKERS: The LOC reserves the rights to substitute devices that simulate the sound of a shot gun.

NOTE:

1. The starting dog in the All-Age stakes will be determined by using the last two digits at the closing of the Toronto Stock Exchange (TSE) S&P/TSX composite index on Wednesday immediately preceding the trial.
2. Rotation: A system of rotation will be implemented for All-Age stakes after the first series (See CKC Rule Book section 6.6.1 c for details)
3. Judges may disqualify any dog which does not appear within 15 minutes of the time designated for its turn to be tried
4. Dogs will run in order unless excused by the marshal for that stake
5. Bitches and dogs will run in the order drawn. Bitches in season may not run.
6. Retriever Field Trial Rules & Regulations 6.6.1 (a) allow running out of order, if in the opinion of the Field Trial Committee such will result in a reasonable and desirable saving of time in the conduct of the trial. Committee members while engaged in any administration function are in this classification.

CANADIAN KENNEL CLUB – Non-member participation fee

- a) An annual fee for awards and titles will be charged to a Canadian non-member of the CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled.
