Entry fees will be refunded for bitches in season or for injured dogs, upon receipt of a veterinarian's certificate.

(The \$9.61 plus HST listing fee, in Canadian funds, must be submitted for any dog not having an individual registration number.)

Standard CKC Rosettes will be awarded to all placing dogs.

PLEASE NOTE: Effective January 1, 2011 - Non-Member Participation Fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
