CKC Registration or ERN must be applied for within 30 days of the trial or all awards will be cancelled. Refunds must be requested in writing and must be accompanied by a veterinarian's certificate. Make all fees payable to the BCAFTC.

A system of rotation will be used for the start of subsequent series in the All-Age Stakes. Wingers may be used in all stakes. Female dogs will not be vetted and handlers are reminded that bitches in estrus cannot compete in a CKC Licensed Trial.
