It is understood that this agreement is binding upon the participant, or his heirs, his executors and assigns.

### **NOTICE TO TRIALERS**

**Excerpt from CKC Rules & Regulation for Hunt Tests: Chap.18: Sec.7:** “It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at a hunt test held under these regulations, is not subjected to indignities of any kind. The Hunt Test Committee Chair shall promptly report to the Canadian Kennel Club any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating this has occurred.”

Judges shall have the power to disqualify any dog which shall not appear within fifteen minutes of the time designated for its turn to be tried, and to turn out of the stake any dog which does not obey its handler or any dog which they consider unfit to compete. Bitches in season may not compete and must be withdrawn. The entry fees of all such dogs shall be forfeited except in the case of bitches in season.
