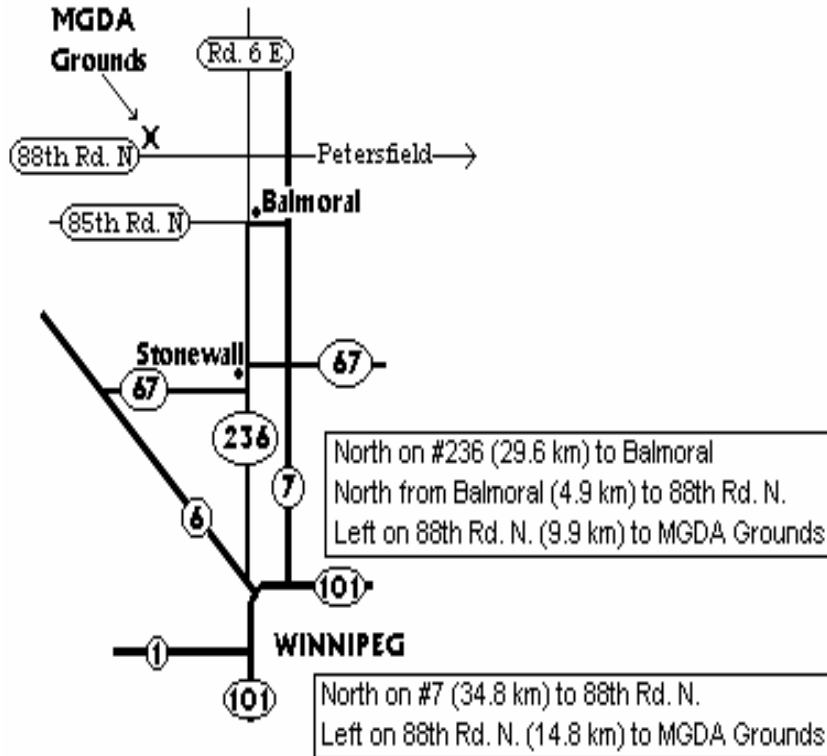

### ENTRIES

1. Make all cheques payable to the Manitoba Gun Dog Association. **Cheques dated no later than the closing date. Please mail early.**

3. Entries CLOSE Monday, August 2, 2010.
4. Draw will take place at 7:00 PM on Monday, August 2, 2010 at the home of the Hunt Test Secretary, 26 Rockcliffe Rd., Winnipeg, MB. All dogs will run in order drawn.
5. **A separate entry form for EACH DOG in EACH STAKE is required. PLEASE USE THE OFFICIAL C.K.C. ENTRY FORMS SUPPLIED, OR COPY OF SAME.**
6. All entries **MUST** be accompanied by the entry fee (and Listing fee of \$8.51 if applicable) in full. A listing fee of \$8.61 (includes G.S.T.) per dog per event is payable unless the dog's entry carries a CKC individual registration number or ERN number.
7. **No phone entries.**

**SCRATCHES:** Will forfeit \$15.00. To be considered, "NO SHOW" refunds must be requested in writing to the Hunt Test Secretary no later than fourteen days after the trial, explaining the reason for the scratch.

**DUCKS, PHEASANT, CHUKAR and/or PIGEONS:** May be used in all stakes; live pigeons, ducks or Chucker may be used for the upland hunting test in the Master Hunt Test.

**CLOTHING:** Competitors, judges and throwers should wear dark or camouflaged clothing.

**STANDARD CKC ROSETTES:** Will be awarded to all dogs qualifying in each stake.

**CAMPING and TRAILER PARKING:** Available. No electrical hook ups, no water.

### IMPORTANT NOTICE TO EXHIBITORS

Any person participating in any capacity at a field trial held under these rules shall not be subjected to an indignity of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out. On report to the trial-giving club of an alleged indignity of any kind, the field trial committee of the club shall forthwith conduct an investigation and shall at once render its decision to all parties concerned. It shall also within ten days after the trial, report to the CKC the nature of the alleged indignity, the names of the parties concerned and its findings. The Discipline Committee of the CKC shall have the power to take such action as it deems fit on receipt of the report indicating that this rule has been violated.

**Caution:** The Manitoba Gun Dog Association (MGDA) will not be responsible for any loss or damage to any dog or to any equipment, whether the result of an accident or otherwise. Furthermore, the MGDA will assume no liability in the event of an accident of other misfortune to event participants, bystanders, club members, workers of other individuals using the property for any purpose.

#### Release and indemnification of Landowners and the MGDA

By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owners(s) of the property upon which the event is held, together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog, or property of the participant howsoever caused, arising out of or in connection with the participant's use or entry upon the property. It is understood that this agreement is binding upon the participant and all of his heirs, executors and assigns.
