TEST DETAILS:

- Running order will be determined by a draw; if possible handlers with more than one dog will run in non-consecutive order. Include name of handler on entry form. A running list will be available at the tests.
- Handlers running more than one event must check-in with Marshalls at both events.
- Pigeons and/or game birds will be used on land.
- Ducks will be used in water.
- Separate entry forms must be completed for each dog and each test entered.
- All handlers in the hunt test must wear dark or camouflage clothing.
- Bitches in season may NOT be entered in the Hunt tests. Refunds will be given upon receipt of a veterinarian certificate PRIOR to the test.
- Lunch will be available at the headquarters for a \$6.00 fee includes meat or vegetarian option, salads, beverage and deserts. **Lunches must be pre-ordered no later than during registration.**

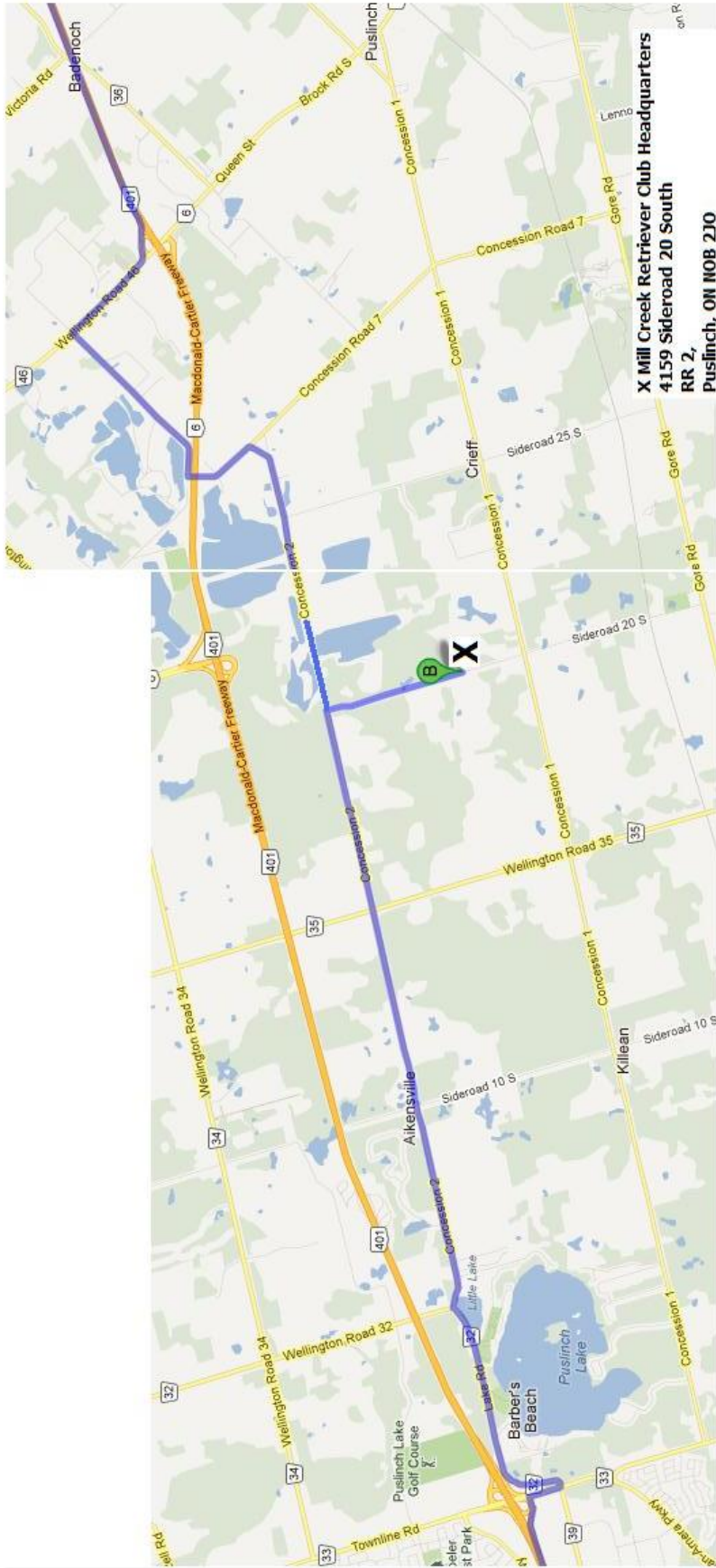
