3. Draw at 8:00 PM on Thursday, September 8, 2016 at the home of the Working Certificate Test Secretary.
4. All dogs will run in the order drawn.
5. A separate OFFICIAL CKC ENTRY FORM for EACH DOG in EACH STAKE is required.
6. All entries must be accompanied by the Entry fees and, if applicable, the Listing fees. A Listing fee of \$8.93, which includes GST, per dog per event is payable unless the dog's entry carries a CKC individual registration number or ERN number.
7. **"Day of" Entries will not be accepted.**
8. **No phone entries.**

**Non Member Participation Fee** "these fees apply only to dogs wholly owned by Canadian non CKC members and are not applicable to CKC members."

**SCRATCHES** will forfeit \$15.00. To be considered, "NO SHOW" refunds must be requested in writing to the Field Trial Secretary no later than fourteen days after the trial, explaining the reason for the scratch.

**DUCKS and/or PHEASANTS** may be used in all stakes.

**STANDARD CKC ROSETTES** will be awarded for all passes in each stake.

**CAMPING and TRAILER PARKING** available. No electrical hook ups; no water.

## IMPORTANT NOTICE TO EXHIBITORS AND JUDGES

### 3.6 Indignities to a Judge

3.6.1 A judge officiating at a test held under these rules shall not be subjected to any indignities of any kind during the progress of the test. It shall be the duty and obligation of the club holding the test to see that this rule is effectively carried out.

### 3.7 Judge's Conduct

3.7.1 A judge must conduct himself in a manner that is fair and not prejudicial to the sport.

14.7 It shall be the duty and obligation of the event-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.

The Manitoba Gun Dog Association Inc. will not be responsible for any loss or damage to any dog or to any equipment, whether the result of an accident or otherwise.
